Emeritus Status	Granted by UBC Senate to those eligible for emeritus status. See <i>UBC</i> Senate Policy V-250.2 Emeritus Status
Complimentary parking in designated areas	For UBC Senate-designated Emeriti. Also, for retired non-emeritus faculty with 25 years of full-time service who are no longer on the UBC payroll Visit: <i>UBC Quarter Century Club</i> .
Library card (aka UBCcard)	Free for faculty retirees at UBC-V and UBC-O
UBCcard (aka Library card)	Provides free access to MOA, Nitobe & Botanical Gardens, Beaty Biodiversity Museum. UBC-V: Price reduction on some items at UBC-V Bookstore, other campus venues. UBC-O? Unknown at present.
Internet and E-mail	Free continuance for faculty retirees.
UBC Faculty Pension Plan (UBCFPP)	Option to leave pension funds within the UBCFPP and/or move funds to external financial institution(s). May transfer in registered funds from a Canadian financial institution or a previous employer. May also rejoin after leaving the FPP.
UBC Retirement and Survivor Benefits Program (RSB) health insurance: Optional enrollment	Administered by Sun Life. Includes Extended Health Care (EHC) (with limited emergency travel insurance); Dental; Employee & Family Assistance Program (EFAP). NB: 31day deadline to join after retirement date.
Additional health insurance plans for travel, extended health care (EHC) and dental insurance secured by UBC Emeritus College: <i>Optional enrollment</i>	Members of the UBC Emeritus College, those eligible for membership and UBC faculty working past age 71 have access to the following: 1. MEDOC (travel); 2. Johnson Inc: Combined EHC/ Travel or Standalone EHC and Dental Care plans; 3. RTO: Combined EHC/ Travel and Dental. https://emerituscollege.ubc.ca/health-and-travel-insurance
Life insurance conversion	You can convert your UBC group life insurance coverage to an individual policy when you retire from UBC. https://hr.ubc.ca/benefits/benefit-plan-details/life-insurance/life-insurance-conversion NB: 31day deadline to convert after retirement date.
THE UNIVERSITY OF BRITISH COLUMBIA Emeritus College A formal unit of UBC	Represents <u>all</u> retired UBC faculty, librarians, academic program directors. Enjoy the many benefits, programs and activities. Membership is automatic for UBC Senate-designated emeriti; others eligible to apply.
UBC Tuition Waivers/Reductions	1. Dependent children of UBC Emeriti eligible for tuition waiver (for undergrad. courses). 2. BC residents, age 65 + may be eligible for free or reduced tuition/fees for selected courses offered at BC universities/colleges. 3. UBC Emeriti age 65+ eligible for 12 credits /yr of free tuition (undergrad. & graduate) UBC courses.
Recreation & Athletics	UBC-V: Qualify for Seniors rates UBC-O: Qualify for faculty/alumni rates.
Office/lab/performance space & other academic support	Not automatic—must be negotiated with your Department.
